VISION OF THE ASSOCIATION

Preserved nature and the environment are fundamental values of the society in which we approach through the application of the sustainable development.



1. SUMMARY

Numerous shifts at the program level, but also at the organizational level, marked 2019. We continued to strengthen our capacities in the field of nature and environmental protection, environmental law and education, marine research, development of professional studies and management plans, and the recognition of the Association as a relevant stakeholder on these issues.

At the organizational level, two departments have been established - the Department of Environmental Law and the Department of Education and Public Informing. Both departments horizontally connect the program and other activities of the Sunce and enable us to achieve even better the set goals of the Association.

Within the Nature Conservation Program, a number of services related to marine research and management of the sea and protected areas were successfully implemented, and the implementation of the LIFE Artina project and several Interreg projects related to marine conservation was intensified. The analysis of the legal framework and communication with fishermen has made a significant contribution to sustainable fishing and the establishment of joint management. For the first time, we participated, within the consortium (Safege, Biom Association and Association Sunce Split), in the tender of the Ministry of Environmental Protection and Energy (as the client) for Natura 2000 ecological network and protected areas management service. The implementation of the Service was approved and started in 2020. We continued to address the issue of marine litter, as one of the growing problems in the marine environment. The draft Action Plan for Visitation Management in the Significant Landscape of the "Northwestern Part of Dugi otok" has also been completed.

With the "Conference on volunteering in protected areas" we successfully completed the project "VOLUNTEER FOR NATURE, VOLUNTEER FOR YOURSELF! - school volunteer program in protected areas of nature", with which we educated and involved in volunteering in protected areas as many as 70 school volunteers. Work on volunteering in protected areas continued with the service of developing new volunteer programs for the Mljet National Park.

Within the Environmental Protection Program, cooperation at the local level has been intensified on the issue of Marjan Park-Forest and remediation from bark beetle infestation, as well as on waste management in Split and education and informing citizens on this topic. However, despite the cooperation with the City of Split on these issues, the situation with the Marjan Park-Forest, as well as with waste management, is still unsatisfactory. Successful cooperation has been hampered by the large influence of policies and individual interests that prevent problem solving and focusing on achieving common goals.

Furthermore, expert analyses of legislation related to nature and environmental protection were made and, in addition to the above, the work of the Department of Environmental Law continued to contribute to the development of environmental law in Croatia and to be involved in significant environmental procedures. Part of the proceedings were completed in favour of the Association Sunce Split. The activities of the Department of Education and Public Informing were largely focused on education on sustainable waste management, so the Association Sunce Split was recognized as a significant actor in conducting and organizing this type of education for various target groups. This recognition has enabled successful participation in tenders and obtaining a range of services on this topic. We also continued to implement and develop socially useful learning programs, and at the celebration of the 45th anniversary of the founding of the Faculty of Economics in Split, we received recognition for cooperation and development of socially useful learning at this faculty.



During 2019, we also concluded an agreement on cooperation with the Split-Dalmatia County for the purpose of long-term cooperation and promotion of sustainable tourism and cooperation within the program of environmentally responsible management of small tourist facilities (Dalmatia Green). All these activities were accompanied by significant communication and promotional activities, so the presence in the media was more than double compared to 2018, i.e., the largest in the last five years.

We would also point out that on an annual basis, the number of full-time employees increased from 11 employees in 2018 to 14.7 employees in 2019. At the same time, the share of self-financing increased almost threefold, from 6.6% to 18.2%. The challenges we faced during 2018, such as the growing number of projects that do not include pre-financing and require a larger amount of co-financing, administrative burdens of individual EU projects and staff turnover, continued in 2019. However, all these challenges have been successfully addressed. Due to the application of new regulations according to which the VAT system is entered during the year when the realized value of the delivery of goods or services reaches the amount exceeding HRK 300,000.00, from October 1st, 2019, we entered the VAT system. Entering the system during the year caused certain challenges in charging VAT for those services that were contracted while we were not yet in the system.

The chapters below provide an overview of program activities and activities related to organizational development in 2019.
